
### **ATMMs**

### **HUGO NOMS STILL OPEN**

Nominations for the 2010 Hugo Awards (for work in 2009) will be open through 13 March 2010. You must have been a member of last year's Worldcon (Anticipation, Montreal) or have joined this year's Worldcon (Aussiecon 4, Melbourne Australia) by the end of January to nominate. The Hugo Awards are for excellence in the field of science fiction and fantasy. They were first awarded in 1953, and have been awarded every year since 1955. The awards will be presented during Aussiecon 4, the 68th World Science Fiction Convention, to be held 2–6 September 2010. The current categories are: Novel, Novella, Novelette, Short Story, Related Work, Graphic Story, Dramatic Presentation (Long Form), Dramatic Presentation (Short Form), Editor (Short Form), Editor (Long Form), Professional Artist, Semiprozine, Fanzine, Fan Writer, and Fan Artist. The John W. Campbell Award for best new writer is not a Hugo, but is administered by the Worldcon using the Hugo rules.

### POTTER-RELATED EXHIBIT ENCHANTS B'HAM

UAB is hosting the traveling exhibit "Harry Potter's World: Renaissance Science, Magic and Medicine" 25 January–5 March 2010. It will reside in UAB's Museum of the Health Sciences <www.uab.edu/historical/museum.htm>, on the third floor of the Lister Hill Library of the Health Sciences, 1700 University Boulevard, Birmingham. The exhibit shows how Rowling delved into the writings of real 15th and 16th century physicians, scholars, and scientists to fashion the basis of magic in the Potter books.

The exhibit is open 9A-6P Monday-Friday during its tenancy at the museum. It will also be open 10A-2P on two Saturdays; 6 and 20 February. The exhibit is free and open to the public.

### 2011 WORLDCON OFFERS YA RATE

Renovation, the 2011 World Science Fiction Convention, has announced a reduced rate available to young adults ages 17–21. Folks under 17 (as of 17 August 2011, the first day of the convention) are still eligible for the children's rate and us old fogies will still pay the full adult tariff. The targeted group is eligible for full memberships at a reduced rate.

The current YA rate is \$100, compared to the current child rate of \$75 and the current adult rate of \$140. All are subject to increase as the con grows closer. (The Worldcon at-the-door adult rate has been \$200 or more for the last decade and one can guess that Reno will be no exception.)

Members in the YA age range who have already purchased full adult memberships will be issued refunds but they will need to contact the convention. Full details of the YA membership are available from Renovation's web site <www.renovationsf.org> or by emailing <memberships@renovationsf.org>.

Chair, Patty Wells, is quoted as saying "I strongly believe that we need to do more to attract young people, especially when so many of them are discovering the genre through writers such as J.K. Rowling and Stephenie Meyer. Our YA rate will allow these new fans to be part of the Worldcon experience: meeting and listening to writers; exploring our art show, dealers' room and exhibits; and attending the Hugo Award Ceremony, Masquerade and other special events."

Fans north of the border may be interested to know that the Canadian Unity Fan Fund is a contested race this year, reportedly for the first time since 2003. The candidates are Diane Lacey and Rob Uhrig. Voting ends soon (25 February 2010) with the winner scheduled to attend Keycon <keycon.org>, to be held 22–24 May at the Radisson Downtown in Winnipeg MB.

### WORLDCON SHORT STORY CONTEST

The 2011 Worldcon is getting a jump on con-related activities by sponsoring a "Make Ready" Short Story Competition. Criteria for entries include: being in English,1500 words or less (including the title), being an original unpublished story, use of the phrase "make ready," including an Australian landmark or town, and being sf, fantasy, speculative fiction, or horror. The deadline for entry is midnight AEST 30 April 2010—some 16 months before the con begins.

There are cash prizes for first and second place (\$200/\$100AUD). Judging will be by a panel selected by Aussiecon and winners will be notified by 31 May 2010. The winners may be invited to read or have their work read at an Aussiecon 4 event. Submission is to be by email (.txt, .doc, or .rtf format) to <shortstory@aussiecon4.org.au>. ### SKIFFY VIDEO GAMES MEET SCIENCE

An assistant professor (Matthew Belmonte) at Cornell University received a National Science Foundation award of \$700,000—funded by stimulus dollars—to study the differences in autistic and non-autistic brains. His tools? Magnetic resonance imaging, high-density electroencephalography, and sf-themed video games with embedded experimental scenarios. The kids (both autistic and not) learn the games, then play them and encounter the scenarios while the prof peels back their brains (in a virtual sense) using the other two tools.

# Movie Awards— Yin and Yang

The Academy of Motion Picture Arts and Sciences <www.

oscars.org>has ann o u n c e d the nominees for the 82<sup>nd</sup> round of the Oscars. Genre and related (in the case of *Sherlock* 



Holmes somewhat distantly related) films came away with nominations in most of the categories—including nabbing three of the ten slots in the headliner Best Motion Picture category. Winners will be announced 7 March 2010 at a ceremony broadcast from the Kodak Theatre in Hollywood CA.

The top genre/related nominee was *Avatar* with nine nods—Best Motion Picture, Directing, Editing, Original Score, Cinematography, Art Direction, Sound Editing, Sound Mixing, and Visual Effects. *Up* followed with five honors, for Best Motion Picture, Animated Feature Film, Original Screenplay, Original Score, and Sound Editing.

Two films came away with four nods, *District 9* (Best Motion Picture, Editing, Adapted Screenplay, and Visual Effects) and *Star Trek* (Makeup. Sound Editing, Sound Mixing, and Visual Effects). One film copped three noms—*The Princess and the Frog* got a nod for Animated Feature Film and two nods for Original Song.

Three movies got two nominations apiece—Fantastic Mr. Fox (Animated Feature Film and Original Score), The Imaginarium of Doctor Parnassus (Art Direction and Costume Design), and Sherlock Holmes (Art Direction and Original Score).

Eight films captured one nom—Coraline (Animated Feature Film), Granny O'Grimm's Sleeping Beauty (Animated Short), Harry Potter and the Half-Blood Prince (Cinematography), La Dama y la Muerte (Animated Short), The Lovely Bones (Supporting Actor), A Matter of Loaf and Death (Animated Short), Miracle Fish (Live Action Short), and Transformers: Revenge of the Fallen (Sound Mixing).

That last marks an overlap point with our next subject.

On the (often well-deserved) hate side of the ledger, there's the Razzies <www.razzies.com>. The 30th Annual Razzie ®

Award Nominees include lots of genre nominees, as is usual for the Golden Raspberries. The summary below doesn't count three special Worst of the Decade categories.

Two films "led" the genre pack with seven dishonors each. Land of The Lost received noms for Worst Picture, Worst Director, Worst Actor, Worst Supporting Actor, Worst Screen Couple, Worst Remake, Rip-Off



or Sequel, and Worst Screenplay. *Transformers: Revenge of The Fallen* was recognized in the Worst Picture, Worst Director, Worst Actress, Worst Supporting Actress, Worst Screen Couple, Worst Screenplay, and Worst Remake, Rip-Off or Sequel categories.

G.I. Joe: The Rise of Cobra garnered six nominations—Worst Picture, Worst Director, Worst Supporting Actor, Worst Supporting Actress, Worst Remake, Rip-Off or Sequel, and Worst Screenplay. Twilight Saga: New Moon got "only" four nods, for Worst Supporting Actor, Worst Screen Couple, Worst Remake, Rip-Off or Sequel, and Worst Screenplay. The least-worst genre film in the list is Imagine That with one nomination for Worst Actor.

# **Awards Roundup**

### **HWA ANNOUNCES WINNERS**

The Horror Writers' Association <www.horror.org> has announced that the winners of the 2009 Bram Stoker Award for Lifetime Achievement (for "substantial influencing the horror genre") are Brian Lumley and William F. Nolan. Additionally, the winner of the 2009 HWA Specialty Press Award is Tartarus Press <freepages.pavilion.net/tartarus/>. This latter award is for "a specialty publisher whose work has contributed substantially to the horror genre, whose publications display general excellence, and whose dealings with writers have been fair and exemplary."

Both awards will be presented at the World Horror Convention <www.whc2010.org>, to be held 25–28 March 2010 at the Royal Albion Hotel in Brighton, England. Memberships are sold out, but some transfers may be available.

### ALA HONORS GENRE WORKS

Among the awards announced at the American Library Association's <a href="www.ala.org">www.ala.org</a>> midwinter conference held in Bos-

ton 15–19 January 2010 were some notable genre wins. The **Newbery Medal** (for distinguished contribution to American literature for children) was won



by Rebecca Stead for When You Reach Me. The Michael L. Printz Award (for excellence in young adult literature) went to Libba Bray for Going Bovine. Both The Monstrumologist, Rich Yancey and Tales from the Madman Underground: An Historical Romance, 1973, John Barnes were listed as Printz Honor books.

The ALA's **Alex Awards** are given to ten books written for adults that have special appeal to young adults. Genre winners included *Everything Matters!*, Ron Currie, Jr., *The Magicians*, Lev Grossman, and *Soulless*, Gail Carriger. Also, *Moribito II: Guardian of the Darkness*, Nahoko Uehashi, with illustrations by Yuko Shimizu, translated by Cathy Hirano was a Mildred L. Batchelder Honor book for best translation.

### CRAWFORD AWARD WINNER

The **William L. Crawford Award** (for an outstanding new fantasy writer whose first book appeared the previous year) is presented annually at the International Conference on the Fantastic in the Arts. This year's award went to **Jedediah Berry** for *The Manual of Detection*. Other nominees were Deborah Biancotti (*A Book of Endings*), Kari Sperring (*Living with Ghosts*), and Ali Shaw (*The Girl With Glass Feet*). The selec-

tion committee also commended two other authors ineligible for technical reasons-Robert V.S. Redick whose first novel appeared in 2008 and Michal Ajvaz whose novel was translated into English in 2009 after appearing first in Czech in 1993.

### GOLDEN GLOBES SHINE ON GENRE

Genre works did fairy well in this year's Golden Globe Awards <www.goldenglobes.org>, sented by the Hollywood Foreign Press Association. Both *Avatar* and *Up* scored two wins—the former won Director, Motion Picture and Best Motion Picture, Drama while the latter copped Animated Feature Film and Original Score, Motion Picture. A not-really-genre-butclose film, Sherlock Holmes, secured the Actor in a Motion Picture, Comedy or Musical trophy for Robert Downey Jr. Genre works



were, however, shut out in the Globes' TV categories and lost to non-genre films in the movie Screenplay, Supporting Actor, and Original Song categories.

### DGAs NOT KIND TO GENRE

Unlike the Golden Globes above, the Director's Guild of America Awards <www.dga.org> pretty much passed over genre works. In two movie categories and seven TV categories, only genre elements in some of the TV commercials cited for Tom Kuntz (winner, Direction in Commercials) could be claimed as a genre win. Even then, some of the commercials he was credited with were decidedly non-genre.

### SAG AWARDS NEARLY A CLEAN MISS

The 2010 Screen Actors Guild Awards, presented Saturday

23 January 2010, included no genre winners in the major categories for either movies or TV. The Stunt Ensemble categories did include trophies for Star Trek (Outstanding Performance by a Stunt Ensemble in a Motion Picture)



and the genre-related 24 (Outstanding Performance by a Stunt Ensemble in Television Series).

### **DWARF STARS WINNERS**

The winner and runners-up for the 2009 Dwarf Stars Award <www.sfpoetry.com/dwarfstars.html> have been announced by the Science Fiction Poetry Association. The award is for the best short speculative poems of 10 lines or less published in 2008. The winners are:
